

Terms of Service

Marina4Art, LLC ("**Marina4Art**," "**we**" or "**our**") provides a service for commercially exploiting digital images of works of art (the "**Services**") through our website, accessible at www.marina4art.com (the "**Site**"). Please read carefully the following terms and conditions ("**Terms**") and our Privacy Policy, which may be found at www.marina4art.com/privacy and which is incorporated by reference into these Terms. These Terms govern your access to and use of the Site and Services, and constitute a binding legal agreement between you and Marina4Art.

Certain areas of the Site and your access to certain Services may have different terms and conditions posted or may require you to agree with and accept additional terms and conditions. If there is a conflict between these Terms and the terms and conditions posted for a specific area of the Site or for specific Services, the latter terms and conditions shall take precedence with respect to your use of or access to that area of the Site or Services.
